ROLE AND RESPONSIBILITIES

Cauda Equina Foundation, Inc. is a 501(c)3 charitable nonprofit that serves to improve the quality of life and care for individuals living with cauda equina syndrome. Our Board of Directors lead the way to achieving our mission.

- Take care of the organization by ensuring prudent use of all assets, including facility, people, and good will; and provide oversight for all activities that advance the nonprofit's effectiveness and sustainability. (legal "Duty of due care")
- Make decisions in the best interest of the nonprofit corporation; not in his or her self-interest. (legal "Duty of loyalty")
- Ensure that the nonprofit obeys applicable laws and acts in accordance with ethical practices; that the nonprofit adheres to its stated corporate purposes, and that its activities advance its mission. (legal "Duty of obedience
- Serving as a trusted advisor to the CEO as s/he develops and implements the strategic plan
- Reviewing outcomes and metrics created by Cauda Equina Foundation for evaluating its impact, and regularly measuring its performance and effectiveness using those metrics; reviewing agenda and supporting materials prior to board and committee meetings
- Approving the annual budget, audit reports, and material business decisions; being informed of, and meeting all, legal and fiduciary responsibilities
- Contributing to an annual performance evaluation of the CEO
- Assisting the CEO and board chair in identifying and recruiting other Board Members
- Partnering with the CEO and other board members to ensure that board resolutions are carried out
- Serving on committees or task forces and taking on special assignments
- Representing Cauda Equina Foundation to stakeholders; acting as an ambassador for the organization
- Ensuring Cauda Equina Foundation's commitment to a diverse board and staff that reflects the communities we serve.
- Providing hands-on leadership to lead the organization to its set goals.

FUNDRAISING

Board Members will consider Cauda Equina Foundation a philanthropic priority and make annual gifts that reflect that priority. So that Cauda Equina Foundation can credibly solicit contributions from foundations, organizations, and individuals, we expect to have 100 percent of Board Members make an annual contribution that is commensurate with their capacity.

BOARD TERMS/PARTICIPATION

Cauda Equina Foundation, Inc. Board Members will serve a two-year term to be eligible for re-appointment for two additional terms. Board meetings will be held quarterly on a virtual network, and a mandatory in-person annual meeting held in early December. Committee meetings will be held in coordination with full board meetings and as needed in between meetings. Board meeting will be a minimum of half day events and up to two days on the day(s) and time(s) agreed on at the previous board of directors meeting. The annual in person meeting will be two full days starting in 2018.

QUALIFICATIONS AND EDUCATION REQUIREMENTS

Cauda Equina Foundation, Inc. is looking for experienced professional board members to guide the organization to its achieve its mission. There are currently no minimum education requirements for limited position(s) on the board of directors that enhance personal knowledge of living with cauda equina syndrome.
